



## VITAL FACTS that counter the Government's narrative on the COVID-19 VACCINE



Is the COVID-19 CoronaVirus destroying as many lives as the Government's policies, which they claim are intended to save lives? Here are some key facts that BBC and other corrupt television media determinedly keep from you.

- As at 09Dec2020, the Government has committed **over a Billion pounds of our (taxpayers') money** to buy a total of **147 Million vaccines** from **Pfizer/BioNTech, Moderna and Oxford/Astra Zenica**, yet **they have not even stipulated that these vaccines should either provide immunity against or prevent spread of COVID-19!** "Success" of vaccines is defined as their reducing symptoms ...and studies show that over 80% of people who have had this virus had either very mild or no symptoms.
- **November 2020, the Government changed the law to make individuals and pharmaceutical corporations involved in making, distributing and administering COVID vaccines immune from prosecution for deaths or any other adverse effects of their vaccines.** (Why would anyone demand that if they had confidence that their vaccines were safe? Do you think that the Chief Executives of those companies are more interested in your health than in pursuit of financially risk-free mega-profits?)
- \* **Pfizer**, the world's largest drug company, **paid \$2.3 Billion to settle charges of fraud and civil and criminal liability over its promotion of off-label use of four drugs in 2009:** the largest healthcare fraud settlement in the history of the US Department of Justice and the largest criminal fine ever. **Pfizer** has also faced thousands of lawsuits filed for medical injuries caused by some of its most popular drugs.
- **Pfizer** and **Moderna** vaccines **change how human RNA works.** No vaccine in history has ever done this. DNA and RNA control our bodies' genetic processing and are absolutely essential to our health and our ability to have children.
- **The Oxford/Astra Zenica vaccine is based on a virus that causes the Common Cold in chimpanzees!**
- **1979-2019, almost £75 Million has been paid from the UK's Vaccine Damage Fund to vaccine-victims** - and, that is for deaths and serious harm caused by vaccines that had typically been tested for 10 years, rather than just a few months.
- **Scientists and medical experts offering alternative views have been censored, silenced and sacked.** The BBC and other Mainstream Media (MSM) have deliberately failed to publish alternative views and **FACTS** which counter the Government's narrative on COVID-19. **Why has open debate been prevented?**



## VITAL FACTS that counter the Government's narrative on the COVID-19 VACCINE



- September 2020, the U.S. “Centers for Disease and Control and Prevention” (CDC) calculated Infection Fatality Rate (IFR) for COVID-19 by age-group, indicating the following age-specific survival rates: -
  - People aged 0-19 years = 99.997% chance of surviving COVID-19;
  - People aged 20-49 years = 99.98% chance of surviving COVID-19;
  - People aged 50-69 years = 99.5% chance of surviving COVID-19; and
  - People aged 70 years or older = 94.6 % chance of surviving COVID-19.

So, for people under the age of 70 the COVID-19 survival rate is between 99.5% and 99.997% whilst for those aged 70 or older the survival rate is 94.6%.

**BEING INJECTED WITH A RUSHED VACCINE THAT HAS NOT BEEN SUBJECTED TO THE STANDARD RIGOUR OF TESTING SEEMS UNLIKELY TO OFFER SUCH POSITIVE ODDS.**

- The MRHA authorised the **Pfizer** vaccine in weeks. The World Health Organisation (WHO) website confirms that **it typically takes an average of 10 years to launch a vaccine. It is not possible to know what potentially tragic effects might emerge a year, 5 years, 10 years, etc. after taking any of these rushed vaccines.**
- **We all have a fundamental legal right to refuse any vaccine or other medical treatment. Informed consent is required** - i.e. based on disclosure of full information, including all possible side-effects; **consent cannot be implied.** However, **it seems that the Government intends breaching this fundamental legal principle.**
- **Vulnerable elderly people in Care Homes** incapable of full understanding and decision-making should not be injected or otherwise treated without the **explicit consent** of their next of kin or person with Power of Attorney over their affairs.
- **Children should not be injected in schools** without their parents’/legal guardians’ explicit consent.
