To whom it may concern,

The time has come for this charade of duality to end. I hereby rebut all presumptions that I am PHILLIP MICHAEL SANDERS (SS# [REDACTED]), a legal fiction/artificial person created to operate in your commercial system. I am Phillip Michael of the Sanders family. I am a natural, flesh and blood, living, breathing sentient being. As a cestui que trust, I am one of the unwilling creditors of this federal corporation, the UNITED STATES. I should be the beneficiary, but the trustee for said trust has been violating their fiduciary duties "ab initio". I demand to have an accounting of said trust. I rebut all presumptions I am dead or lost at sea. I bleed, therefore I live. I have a will, therefore I live. I hand-delivered this writ, witnessed by your office staff, therefore I live. Can a fiction do the same? I hereby CLAIM ALL OF MY UNALIENABLE/NATURAL RIGHTS according to this Maxim, "Those awake, not those asleep, the laws assist."

I rebut the presumption that I am "Federal Personnel" as described in; 5 USC § 552a - Records maintained on individuals (a) Definitions. (13) the term "Federal personnel" means officers and employees of the Government of the United States, members of the uniformed services (including members of the Reserve Components), individuals entitled to receive immediate or deferred retirement benefits under any retirement program of the Government of the United States (including survivor benefits). I rebut the presumption that any license, registration or the like makes me a citizen as defined by your laws and statutes (under color of law). I am a natural born, non-resident alien and hereby claim deceit through non-disclosure for any presumption I surrendered any rights in exchange for privileges.

I hereby demand that my UNALIENABLE/NATURAL rights be protected from this point on. I demand full DIPLOMATIC IMMUNITY as I am foreign to your federal government.
